**ADDITIONAL APPLICATION MATERIALS REQUIRED:**

1. Please enclose four (4) photos of work to be exhibited and one photo of your booth display. Please write your business name on the back of each photo. Applications without photos will not be considered.
2. Please enclose two (2) self-addressed, stamped envelopes so additional information may be sent to you.
3. All work in your booth must be handmade. Inclusion in the festival is based on quality of merchandise as determined by the committee.

**BOOTHS:** All booth spaces are 10 feet by 10 feet. Limit one (1) booth per applicant. The registration fee for each booth is \$200 and optional electricity for your booth is an additional \$25. Registrations must be **postmarked by Thursday, August 1, 2019**. Availability for electricity is limited – 110 amp service only.

**FIRE CODE REQUIREMENTS:** Vendor tents must be **FIRE RESISTANT** with certification sticker attached to the tent. Gas lanterns are not allowed. Battery powered or electric lights must be guarded. Halogen quartz lights are not permitted. All drop cords must be 12-gauge heavy duty in compliance with the laws of the State of North Carolina.

**CERTIFICATE OF INSURANCE:** All Oktoberfest 2019 vendors are required to provide a Certificate of Insurance naming Hickory Downtown Development Association as additionally insured. Please see our website for more information.

**GENERAL RELEASE:** The undersigned does hereby release, forever discharge, and hold harmless the Oktoberfest organizers, Hickory Downtown Development Association, and the City of Hickory of and from all manner of actions, suits, damages, claims, and demands whatsoever in law or equity from any loss or damage to property or the Undersigned while in the possession or supervision of the festival, its agents, representatives, or employees. The Undersigned consents to enforcement of all the festival rules. The Undersigned gives permission for photos or descriptions of their work accepted for Oktoberfest 2019 to be used for festival promotional purposes.
